The amount of appeals reviewed during the year 2004-2005 reflects a total of 25.56% increase over the previous year. The statistic does not include the **deletion appeals** which are now being processed at the Registrar's Office. During the period from November 2004 to May 2005 a total of **141** appeals were processed – out of which **114** were approved, **19** denied, and **8** were sent to the Business Manager's Office.

The heaviest work-load for the committee has always been at the “dismissal” meeting that takes place between semesters.

I. Dismissals

Requests for Academic Dismissal and Probation are initiated through the Registrar’s Office.

In the 2003-2004 academic year, 312 (28.46 %) of the 1096 dismissal appeals were approved. In the 2004-2005 academic year, 000 (00%) of the 0000 dismissal appeals were approved. Those students whose appeals were approved remained on academic probation.

II. Other Issues

The Committee voted to allow the Registrar to process deletions. The percentage of the deletion to be awarded would be ascertained after reviewing the attendance from the rosters.

The issue of Student Government participation in the Committee on Course & Standing was raised. However, since the nature of the appeals often involves confidential student matters, student members will not be present during student appeals. Mr. Michael Mutlu, Treasurer of the student Government, was invited to an introductory meeting, but was unable to attend. He, or another designated student, will be asked to attend future meetings that involve policy and procedures.

The credit limit for students on probation was discussed. The Committee voted to allow Counselors to increase the credit limit of students who are on probation. Some students require a minimum of 12 credits (6 actual) for the Financial Aid purposes.

The Committee Members reviewed guidelines of the Committee on Course and Standing. Editorial changes were made. The guidelines are based on the responsibilities and actions of the Committee. Changes were forwarded to Michele Cuomo, liaison to the committee who will incorporate them into the template.

The Committee Members were apprised of the developments and positive improvements in students seeking counseling. The Counseling Office is persistent in sending letters to students and contacting students by phone, to seek counseling if they are on probation. Dr. Rustin reported that 30-40% of students are complying.

The staff of the Registrar’s Office; Ann Tullio, Xiao Yan Cai, Meera Chowdhry and June Greco have been a tremendous source of support and dedication in their effort to provide the highest level of professional service to the Course and Standing Committee.

It has been the Chair’s privilege to serve with the Course and Standing Committee. The members of this committee are a dedicated group of professionals. This committee has utilized their best judgment to follow committee guidelines to adjudicate compelling and at times, difficult decisions. It is inspiring to be a part of this dedicated and caring committee.

Anne Marie Menendez was reelected as chair of the CCS for the year 2005-2006.
